Joint Statement on the possible reinstatement of the death penalty in Turkey

20/10/2016

At the CCBE Standing Committee in Paris, the CCBE President Michel Benichou presented the joint statement on the possible reinstatement of the death penalty in Turkey.

Following recent comments by the Turkish President on the possible reinstatement of the death penalty in Turkey, the CCBE took the initiative to publish a statement denouncing this possibility. In the statement, it was highlighted that the right to life is "an inalienable attribute of human beings" and a "supreme value in the international hierarchy of human rights".

Furthermore, the organisations underlined that the abolition of the death penalty contributes to the fostering and protection of human dignity. They condemned, in the strongest terms, any attempt to reinstate the death penalty in Turkey and called upon the Turkish government to respect its international commitments, notably that Turkey is a member of the Council of Europe and bound by its protocols (6 and 13) which abolish the death penalty.
