



After the hearing, the prosecutor ordered his detention on charges of "participating in a terrorist group" under Article 87 of the Penal Code, which is punishable by up to 20 years in prison, and for "spreading false news" under Article 196, which could lead to an additional three-year sentence and a fine, for alleged ties with members of Rachad and his participation in public debates on the 2019-2021 Algerian protests, also known as the Hirak movement.
AFGHANISTAN	Afghan Bar	25.11.2021	Click here	Call for the recognition of an independent Bar  The Afghan Independent Bar Association (AIBA) leadership and management are facing high risks because of their efforts to ensure the respect of the rule of law and their work with international organisations and partners, trying to maintain their independence. In this regard, the AIBA agreed and met with the Taliban Justice Minister in order to seek cooperation/collaboration. The discussion in that meeting mainly concentrated on the independence of the AIBA. However, the Taliban Minister of Justice already had created a committee to prepare justifications for suppressing the AIBA so that the Ministry of Justice could have full control on the regulation and access to the legal profession, therefore depriving it of any sense of independence, which is crucial for the integrity of the administration of justice and the respect of the rule of law. Eventually, a plan was then approved by the cabinet of the Islamic Emirate to suppress the AIBA and to prevent the continuation of any independent bar association in the Taliban justice system. This decision has for consequence that all lawyers who were registered under the AIBA are not recognised as such anymore and cannot exercise their legitimate profession, nor appear before a court or represent their clients

He was later convicted on 15 June 2021 for "collaborating with rebels who attacked Burundi" and that on 29 September 2021 the Court of Appeal of Ngozi upheld his conviction to a 5-year prison sentence. Although the prosecution did not produce any credible evidence against Tony Germain Nkina, as well as no prosecution witnesses appeared in court, the court upheld the conviction, quickly issuing its verdict. In the first instance trial, the prosecution accused him, among other things, of travelling to Rwanda to give information to Pierre Claver Mbonimpa, president of the Association for the Protection of Human Rights and Detained Persons (APRODH). It is therefore believed that his imprisonment is politically motivated and based on his former human rights work.

After he complained that Cameroon's criminal procedure had been breached in his client's case, the gendarme in charge of the investigation seized his phone without a warrant, claiming Amungwa had taken photographs at the facility. While searching, the gendarme found other photographs which recorded alleged military abuses in Cameroon's Anglophone regions and decided to arrest him on charges of inciting terrorism.

These charges are linked to the fact that the two lawyers were hired by family members of Hong Kong protesters who were arrested last year while trying to flee to Taiwan by speedboat. On 15 January 2021 Lu Siwei's licence has been formally revoked by the Sichuan Provincial Judicial Department.

It is reported that his defence lawyers were not given the possibility to present a defence statement in accordance with China's Criminal Procedure Law.

It has been reported, however, that these accusations are actually solely being used as a way to retaliate against his legitimate activities as a lawyer, identifying with his clients' causes.

In addition, On 26 November 2021, lawyer Liang Xiaojun was informed by the Beijing Municipal Justice Bureau that his license to practise had been revoked on charges of violating article 49 (1.8) of the PRC Law on Lawyers for spreading online messages on domestic and overseas social media to support Falun Gong, which is banned in China, and discrediting China's legal system. However, although these reasons were not used as such to revoke their license, it is believed that these two lawyers were sanctioned on the basis of their work representing one of the 12 Hong Kong human rights activists, who were caught at sea fleeing to Taiwan last year.
