

He was sent to jail by the court on 26 March. lawyer Kazi Rubayet Hasan Sayem's bail plea had been repeatedly rejected. On 26 April, it is reported that the High Court Division of the Bangladesh Supreme Court denied his bail application. Lawyer Kazi Rubayet Hasan Sayem has now been in jail custody for the past two months.

He remained in preventive detention until 6 September 2021, after which he was sentenced by the Minsk Regional Court to 10 years in prison on charges of "calls for action against national security", "conspiracy to seize power" and "creation and administration of an extremist formation" (Art. 361, 357 and 361-1 of the Criminal Code of the Republic of Belarus). His trial, which took place placed behind closed doors, was considered "arbitrary as it lacked a legal basis, was due to the peaceful exercise of his rights, was the result of violations of his fair trial rights and was based on discrimination based on his political opinion and his status as a lawyer of the political opposition movement".

Lawyer Yulia Yurhilevich was stripped of her licence in February 2022 by the regional bar association of Hrodna, for "systematic violation of the law." Her disbarment was triggered by a complaint from the Hrodna region deputy prosecutor questioning her "professionalism".

We understand that the punishment for this offense ranges from two to six years of imprisonment. It is reported that Mr. Sudalenka remains unsure which of his actions the authorities deemed as constituting "other facilitation of extremist activity".

On 2 March, the high court of Ntahangwa in Bujumbura confirmed their pre-trial detention on charges of rebellion and of undermining internal state security and the functioning of public finances.

These acts of intimidation take several forms, including anonymous threats sent by text message and email, GPS tracking devices placed under a car, Chinese "funeral money" sent to an office, or accusations of disloyalty in the press.

The ONBC is under the control of the Ministry of Justice and its director gives instructions on how to proceed, how to stay within the limits, and how to express oneself in the technical defence, which means that the case has been decided before going to trial. Lawyers who express independent opinions or act in a way that is incompatible

				with the ideals of the State run the risk of being struck off by the ONBC. Lawyers at the Cubalex Legal Information Centre and the Consejería Jurídica e Instrucción Cívica have been subjected to harassment and intimidation.

It is believed that thethreat is also linked to his work as a legal representative of a number of suspects facing charges underthe Suppression of Terrorism Act of 2018.

And it is reported in this regard that El Periódico was notably covering stories of wrongdoing and corruption from the authorities in Guatemala. Tarrest of lawyer Mario Castañeda is connected to and serves to unlawfully curb his legitimate activities as a lawyer defending the freedom of the press. Moreover, the prosecutor in charge of the case is seeking to arrest a second lawyer, Romeo Montoya, who is representing the same client.

Moreover, it is reported in this regard that El Periódico was notably covering stories of wrongdoing and corruption from the authorities in Guatemala against press freedom. The prosecution of these lawyers is politically motivated due to their work representing José Rubén Zamora.

It is believed that these acts are taken in reprisal of their work fighting impunity in cases of serious human rights violations and corruption in Guatemala. To our understanding, several other Guatemalan justice operators are also being prosecuted, including former anti-corruption Prosecutor Virginia Laparra, highlighting the increased

				crackdown on justice operators involved in the fight against corruption and impunity.

Her sentencing is linked to her activism defending human rights and for representing several recently arrested individuals, including media activist Mehrnoosh Tafian, journalist Mandanda Sadeghi, and student activist Ronak Rezaie Additionally, in May 2023, lawyers Mohammad Seifzadeh and Marzieh Nikara, have been sentenced to one year of imprisonment by Branch 29 of the Revolutionary Court in Tehran on charges of "anti- regime propaganda activities" and "dissemination of falsehoods". The case initiated against them originated from a letter drafted by a group of human rights defenders and legal, including the two lawyers to the UN Secretary-General, addressing the suppression and intimidation of citizens during the nationwide protests in 2022-2023.
IRAN	Iranian Bar Association threatened	07/07/2023	Click <u>here</u>	Independence of the Iranian Bar Association threatened on 27 June 2023, a motion titled "the Request to Investigate the Operations of Bar Associations and their Union" was passed in the Iranian Parliament. This motion will enable the judiciary chief and state security agencies, including the Intelligence Ministry and the intelligence organisation of the Islamic Revolutionary Guard Corps, to scrutinise bar associations throughout the country as well as their central union in Tehran. The state security apparatus will also be reportedly empowered with "reviewing the legal qualification" of lawyers who are members of the bar, which will enable it to pick and choose which lawyers are allowed to officially work as lawyers in the country.

The charges brought against him are related to his work as a lawyer in the case of Abolfazl Adinehzadeh, a minor who was killed during the 2022 nationwide protests.
IRAN	Infringement on the Bar Association's autonomy	21/09/2023	Click <u>here</u>	Preoccupying situation of lawyers and their independence Many Iranian lawyers and bar associations have criticised a parliamentary resolution obliging them to adhere to the directives of the Economic Ministry's Regulatory Board without being able to challenge the changes via the Administrative Justice Court, saying that this was "inconsistent with the nation's fundamental rights and an infringement on the Bar Association's autonomy." This was not the first attack against the independence of the legal profession as the Iranian Bar Association has faced persistent pressure from both governmental agencies and the judiciary over the past four decades and that its autonomy and powers have been steadily eroded by a series of legislative measures.
