2. Overview of procedural steps		 The applicant has to send application to the Higher Regional Court of the applicant's chosen <i>Land</i>. The Higher Regional Court will forward the application to the Examination Office at the relevant federal Ministry of Justice of the chosen <i>Land</i>. The Examination Office will carry out an assessment comparing the relevant foreign and national qualifications and professional experiences: it might require the applicant to sit an aptitude test. The aptitude test replaces the 1st State exam. The Examination Office will inform the Higher Regional Court about the outcome of its Assessment (and any aptitude test). After successful completion of the assessment (and any aptitude test) through the Examination Office, the applicant – following the approval of the Higher Regional Court – is eligible to commence with the 2-year traineeship (organised by the Higher Regional Courts). Upon successful completion of the traineeship/any relevant exams, the applicant is eligible to seek registration as a lawyer.

		The applicant has passed the aptitude test if he or she passes the required number of written examinations (2 or 3 tests per field, the number and the fields of law differ between the federal states) under the specific examination regulations of the 1 st State Exam. At least half of the written examinations (5 out of 8 or 9 examinations) as well as examinations in at least 2 of the 3 listed fields (civil law, criminal law, and constitutional and administrative law) have to be passed, with at least 1 written examination passed in the field of civil law.						
		An oral examination is not carried out.
